

Home Pro MI \$15,000 Home Improvement Giveaway

Eligibility: This \$15,000 Home Improvement Sweepstakes (Sweepstakes) is open to all natural persons who are legal residents of Michigan, who are at least 18 years old at the time of entry, and who own a single-family home in west Michigan. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. No purchase is necessary to enter or win. Employees of Home Pro MI (Home Pro) are not eligible to enter. Eligible entrants can enter the Sweepstakes on Home Pro's website.

Limitation on Entries: Only one entry per household will be accepted every 24 hours. Entries are accepted between 12:00 am January 1, 2026, and 11:59 pm December 1, 2026 (Entry Period).

Prize: The prize is a home improvement to prize winner's home in west Michigan with a retail value of \$15,000. The prize is non-negotiable, non-transferable, and non-refundable. No cash alternative is available.

Drawing: Home Pro will select one winner at random on December 2, 2026, and notify the winner on or after this date.

Claiming Prize/Releases: Home Pro will notify the prize winner by email and/or telephone. By accepting the prize, and returning a potential winner affidavit, the winner agrees to release Home Pro and all subsidiaries, affiliates, distributors, and agents from any and all liability, claims, actions, or proceedings arising out of and/or for injuries or damages sustained in connection with the use of the prize and consents to Home Pro's use (for promotional purposes in connection with this Sweepstakes) of its name, and/or voices, and/or photos, and video of the winning property without further compensation.

Completion: Home Pro will endeavor to complete the prize winner's home improvement project no later than June 1st 2027, subject to any circumstances outside of Home Pro's control. The actual timing of the project shall be at the discretion of Home Pro. The home improvement must be within Home Pro's line of work and completed only with products supplied in the normal course of business by Home Pro.

The winner must provide Home Pro with a valid taxpayer identification number before Home Pro awards any prize.
