Multistage Filtration Process

How the Ultrefiner II Drinking Water System Works



Unfiltered water enters the system from the inlet valve.



Water is forced through the pre-filter cartridge which reduces particles and chlorine taste and odor.



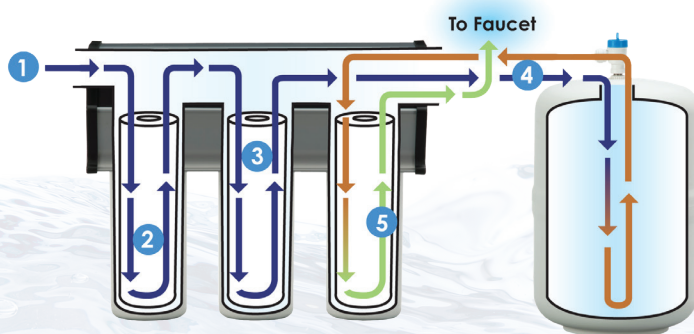
Water then enters the Ultrefiner II membrane cartridge where it is filtered through a spiral wound, semi-permeable membrane.



The resulting highly filtered water enters a storage tank.



Your reverse osmosis water is finally filtered through the system post-filter and dispensed through a dedicated drinking water faucet.
